



## **Milan City Park RV Campground**

Site rental is \$25 per night for a maximum of 14 nights per stay. The installation of permanent camping facilities is prohibited. Exceptions to the length of stay can be reviewed by Park Administration based on circumstances. Only 1 camping unit and 4 people per camping site. There is a \$3.00 per day extra charge for over 4 people (12 years and up).

Check in time is 2:30 p.m. Check out time at 12:00 p.m. (noon).

We prefer that reservations be made a minimum of 48 hours prior to arrival. Reservations can be made by calling Milan City Park at 731-238-3064 between the hours of 8:00 am and 4:00 pm Monday through Friday. If arriving late without a reservation, please call the number listed above to ensure there's an available spot. If so, you may pay for your reservation at the City Park Office by placing it in the mail slot in the door. There are envelopes under the welcome mat for your convenience. *\*Please note, if no reservation is made, electricity and water may be locked and unavailable until the next morning. If arriving on a weekend, please call immediately and we will have a staff member come assist you if needed.*

Camping is only allowed on designated RV sites.

The digging or leveling of the ground at any campsite is prohibited.

Camping equipment must be completely removed and camping sites cleaned by campers before departure.

Campground quiet time shall be maintained in all campgrounds between the hours of 10:00 p.m. and 6:00 a.m. *\*NOTE - Campground is located within our City Park and is in close proximity to recreational fields, etc. that at times may entertain activities that create noise, light, etc. beyond the listed quiet times.*

The gathering of wood for use as fuel in campgrounds or picnic areas shall be limited to dead material on the ground, except where such gathering is prohibited by the Park staff by the posting of appropriate signs.

No golf carts or ATV type vehicles, other than automobiles, are allowed to be used in the park. Some exceptions may be made (with permission from the Park staff) for special events at the saddle club, etc.

Any disorderly conduct is prohibited and will be investigated by the Milan Police Department.

Dogs, cats and other pets are prohibited unless they are crated, caged or on a leash, or otherwise under physical restrictive control at all times. Persons shall clean up a pet's waste in any park area. Failure to clean up the waste is a violation of park rules.

The use or possession of fireworks and firecrackers is prohibited, except upon written permission of the Park Director or Foreman.

The kindling of any fire is permitted only in designated camping and picnic grounds when the fire is confined in a fireplace provided for the use of visitors, or grills, or in locations marked by the Park Staff; or in stoves or lanterns using gasoline, propane, butane gas or similar fuels.

Fires must be kindled in such manner that no tree, shrub, grass, or other inflammable or combustible matter will be set on fire or caused to be set on fire.

When no longer needed, the fire shall be completely extinguished. Leaving a fire unattended is prohibited.

Throwing or dropping a lighted cigarette, cigar, pipe heel, match or other burning material is prohibited.

The Park Staff, during such periods of time as he may prescribe, may prohibit smoking on any or all portions of the park as he sees fit.

Unless further restricted herein or by special regulation, fishing within the park area shall be in accordance with the laws and regulations of the Tennessee Wildlife Resources Agency.

Possessing alcoholic beverages in an open container or consuming any alcoholic beverages is allowed only in the camper's rented campsite. No alcoholic beverages of any kind are allowed in any other area of the park.

All lost articles shall be deposited by the finder at the office of the Park Staff.

Horses and other saddle or pack animals may be permitted by Park Staff if request is made and approval is granted a minimum of 48 hours prior to arrival.

**SANITATION:** All garbage, papers, cans, bottles, waste materials and rubbish of any kind must be disposed of only at points or places designated for the disposal thereof or removed from the area.

Draining or dumping refuse or wastes from any trailer, or other vehicle except in places or receptacles provided for such use is prohibited.

Cleaning food or washing clothing or articles of household use at campground hydrants is prohibited.

Polluting or contaminating in any manner any watershed, water supplies or water used for drinking purposes is prohibited.

Fish entrails or other inedible parts of fish shall not be thrown into fresh waters or onto park area lands in areas of public concentration.

Depositing any bodily waste in any other place except into fixtures provided for that purpose is prohibited. Placing any bottle, can, cloth, rag, metal, wood, or stone substances in any of the plumbing fixtures in such station or structure is prohibited. All comfort stations shall be used in a clean, sanitary, and orderly manner. Urinating or defecating other than at the places provided is prohibited.

Using City refuse containers or other refuse facilities for dumping household or commercial garbage or trash brought as such from private property is prohibited.

Washing of vehicles, trailers, and boats at campground hydrants is prohibited.

All other posted rules and regulations in the City Park apply to park campers and visitors and must be followed as posted.

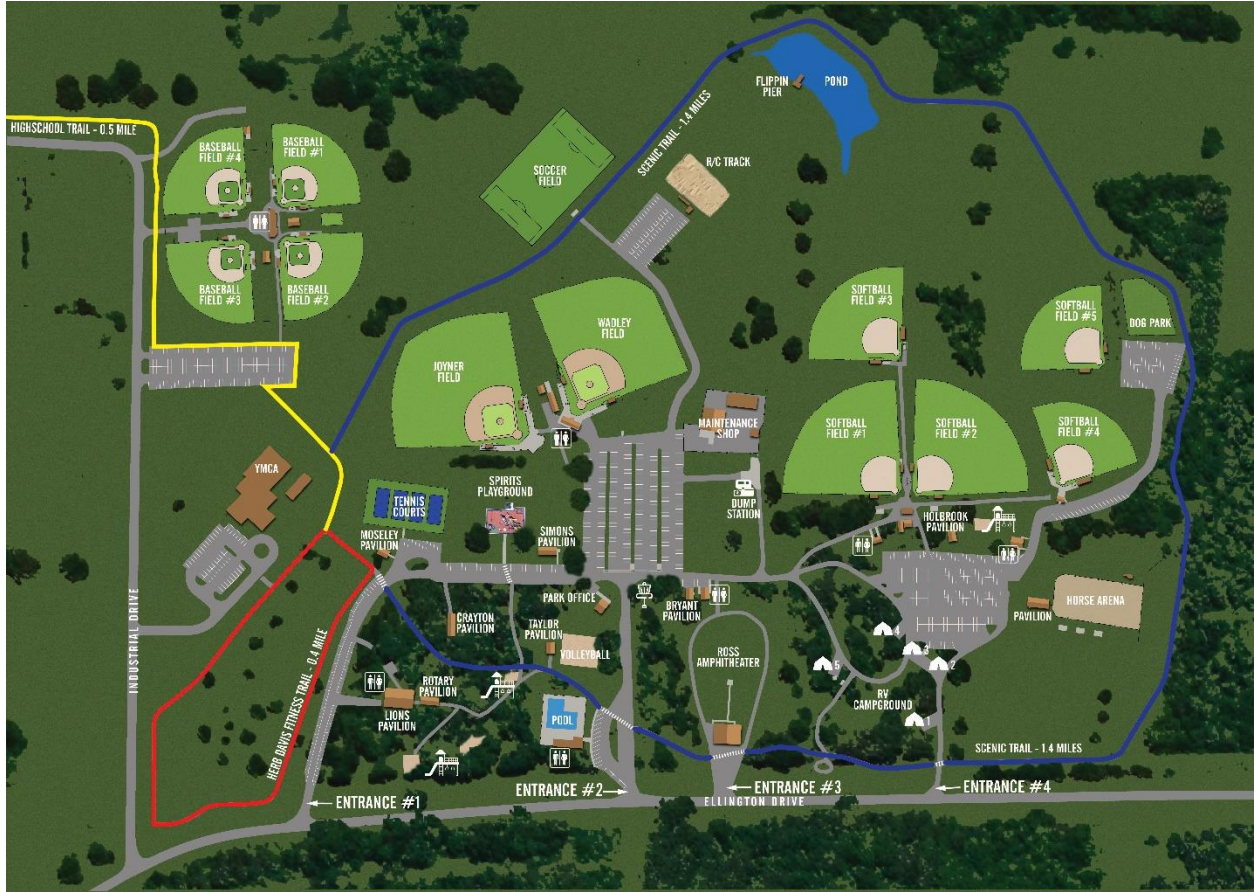
