### Call to Order

Mayor BW Beasley called the Public Hearing to order at 5:20 p.m.

Mayor Beasley opened the floor to receive public input regarding Ordinance 2017-3 (Fence Ordinance).

Mr. Holt Shoaf spoke against amending the Fence Ordinance. Mr. Shoaf stated that the person building the fence ought to have to look at the ugly side of it.

Mr. Jerry Belew spoke for amending the fence ordinance. Mr. Belew advised that he has a building at 1074 West Van Hook Street between a chiropractor's office and Vestal Automotive. Mr. Belew stated that he would like to put up a privacy fence to protect his renters. Mr. Belew advised you have a finished side to a fence and a framing side to a fence, Mr. Belew would like to put the finished side of the fence to his inside and the framing side to the side where the cars are located. The current Fence Ordinance will not allow for him to do that, Mr. Belew is asking the board to consider amending the ordinance to give the builder the option.
